### **Booth Policies and Guidelines**

- Once the booth is registered, there are no refunds or transfers
- Due to limited space, booths will be allocated on a first-come-first-serve basis

- Ganesh Nimajjan committee along with ICCT, reserves the right to review and approve services provided by the booths
- Booths must be set-up between 11:00 AM and 12:00 PM on **Sunday September 8<sup>th</sup>, 2019**
- Booths must be cleared by 8:30 PM on **Sunday September 8<sup>th</sup>, 2019**
- Each individual or group is responsible for the cleaning of their booths
- Prices cannot be changed after the start of the event
- Traditional Indian attire is encouraged
- Booths must stay open till 6PM.
- Extra tables in each booth must placed in a manner such that it does not encroach walkway area or adjacent booth space. For 3 or more tables per booth, the tables will be arranged in "L" or "U" shape
